

Black Belt Poker's Sponsored Player Terms of Agreement

This agreement is made between Black Belt Poker Limited a company registered in England and Wales under Company number 6843953 and having its registered office at No 100 Dean Street, London, W1D 3TF ("Black Belt Poker", "we", "us" or "our") and the Player ("you") named in the Schedule of Particulars forming part of this Agreement (the "Particulars").

* "Make-up" (the restitution of buy-ins to Black Belt Poker) will be subtracted and returned to Black Belt Poker from any returns from poker tournaments before the remaining returns are divided 50% to the Player and 50% to Black Belt Poker.

Any starting make-up values at the commencement of sponsorship will be carried over as a negative balance for individual sponsored players. Value at time of signing:

Small Print

Format:

The Player will compete in a series of live poker tournaments ("events") as prescribed by Black Belt Poker. Black Belt Poker will pay the buy-in and entrance fees for all events that the Player is required to participate in, for as long as the Player remains sponsored. Any tournament returns will be shared between the Player and Black Belt Poker according to the percentages detailed in the Particulars. Payment of Black Belt Poker's share of tournament returns must be made within ten days of participants' receipt of them.

Your Obligations

The Player

1. Will participate in press and media activity as required by Black Belt Poker;
2. Agrees to the use of their image and content provided by them to www.blackbelt poker.com by Black Belt Poker;
3. Will wear exclusively Black Belt Poker merchandise provided during each event which comprises part of the Player's sponsorship;
4. Will professionally represent Black Belt Poker at all times;
5. Agrees to obey the rules of the poker rooms;
6. Accepts that Black Belt Poker reserves the right to have a representative present during any 'deal' discussions during the final stages of events;
7. Accepts that Black Belt Poker will have the deciding say in any acceptance of external sponsorships at final tables etc. and receive a proportion of the payment as mentioned in the Particulars.

General Provisions

The terms and conditions of this Agreement are the only terms and conditions agreed between you and us. All agreements, warranties, representations and other statements made by us or on our behalf by any means before the making of this Agreement are excluded. No variation of this Agreement will be effective unless that variation is made in writing and signed by you and on our behalf by an authorised signatory.

If any provision of this Agreement is held to be invalid or unenforceable no other provision will be affected and all such other provisions will remain in full force and effect.

No person other than you or us will have any right under the Contracts (Rights of Third Parties) Act 1999 to enforce any term of this Agreement. This clause does not affect any rights or remedy of any person which exists or is available otherwise than under that Act.

Our rights under this Agreement will not be affected by any delay or failure in our exercise of any right under this Agreement or otherwise. Any waiver by us of any breach of your Obligations will not in any way serve as a waiver of any future or other breach.

This Agreement shall be construed and take effect in accordance with the laws of England and Wales and you hereby submit to the jurisdiction of the English courts without prejudice to our right to bring proceedings in the courts of any country in which you carry on business.

Payment

The Player is required to pay Black Belt Poker our share of any returns as detailed in the Particulars by either cash, cheque (payable to Black Belt Poker Limited) or bank transfer to *****

Termination

We have the right to terminate this Agreement at any time with immediate effect.
